Thank you for submitting your proposal for a deputy registrar agency. Each proposal has been evaluated for both personal and operational consideration. A site evaluation will be conducted for those proposals which included a proposer-provided location that isn't currently operating as a license agency. The maximum scores this year are as follows:

In accordance with RFP section 1.15, each proposer now has an opportunity to review his or her own proposal as well as any competitive proposal. Be sure to follow all instructions carefully. The deadline for submitting the [Written Response and Comments](#) is 4:00 p.m. on Friday, March 28, 2025.

The final review and selection process will begin after March 28, 2025, and will follow the provisions contained in the RFP, all relevant statutes, and applicable administrative rules. Tentative contract awards are scheduled to be announced on or after Friday, April 11, 2025. Those announcements will be posted on the BMV website at [bmv.ohio.gov/dr-rfp.aspx](http://bmv.ohio.gov/dr-rfp.aspx).
